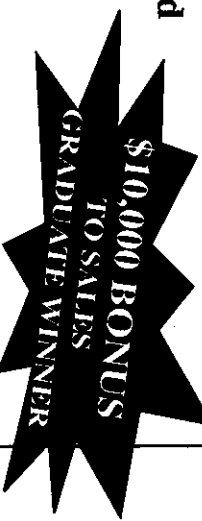

2010 MOUNTAIN TOP NM BRED THOROUGHBRED FUTURITY TERMS AND CONDITIONS

The undersigned represents that he/she and all persons for whom he/she is acting have read and are familiar with the Rules of Racing and Regulations of the New Mexico State Racing Commission and the race meeting conditions and agrees to be bound by and comply with the same and with the acts and decisions of the New Mexico State Racing Commission and the Ruidoso Downs Racing, Inc. officials, and that all horses are subject to the same and to the acts and decisions of the race officials, and agree to be bound by the following terms and conditions. All stable reservations and entries in stakes and all other races are received and accepted subject to all conditions, rules and regulations of the New Mexico State Racing Commission and Ruidoso Downs Racing, Inc. All horses, either by time or performance, that do not meet Ruidoso Downs Racing, Inc. minimums, will be asked to vacate their stalls. Time and/or performance standards will be set prior to the opening of each race meeting. It shall be the Nominator's responsibility to notify the Association of ownership and address changes. It shall be the nominator's responsibility to make timely payments. If the deadline for a payment falls on a Saturday, Sunday, or legal holiday, the period is extended to include the next day that is not a Saturday, Sunday, or legal holiday.

For any horse entered as a participant in a competition to be held by Ruidoso Downs Racing Inc., Ruidoso Downs Racing Inc. reserves the right to require said race horse to remain on the grounds of Ruidoso Downs Race Track from the time of entry and through the day of said competition and to require said horse be made available for drug testing at any time following entry into said competition and through the completion of said competition. Ruidoso Downs Racing Inc. further reserves the right to drug test any and all horses on the grounds of Ruidoso Downs Race Track.

ELIGIBILITY AND NOMINATIONS.

The race is open to all foals of 2008 which are registered with The Jockey Club and are also registered New Mexico Bred. Complete payment schedule for the Futurity is on the front of this form. An advertising/clinical fee of 5% will be deducted from all fees. Nominations to Futurities and Derbies do not guarantee stall space. Ruidoso Downs Racing, Inc., reserves the right to have its track veterinarian inspect any nominee for age verification.

An owner may nominate as many horses as they wish. If one or more horses are withdrawn before the race, those horses being withdrawn must be specified at time of payment.

Please list the names of all entries on payments. Nominations or subscriptions to this stake may be refused or canceled, without liability, at any time prior to the actual running thereof, except for the return of any nomination and entry fees paid.

Nominations and sustaining fees will be accepted after the payment deadline only through the United States Mail, postmarked (by the U.S Post Office) no later than midnight of the payment deadline. For all nominating and sustaining payments except the trial entry fee, there will be an automatic (no penalty) graceperiod of 48 hours in establishing acceptable postmarks. In case of dispute, the only satisfactory evidence of payment shall be certified mail receipt or a registered mail receipt bearing a United States Post Office postmark on or before the stated due date. For all nominating and sustaining payments, except the trial entry fee, during a period including the thirtieth (30) day following each deadline, any owner may reestablish their entry(ies) eligibility by submitting a per entry payment of twice the regular fee due on the prescribed deadline. This thirty (30) day period shall be reduced in cases where the trials for the race are being run prior to the expiration of this thirty(30) day period. In such cases, a per entry payment of twice the regular fee must be submitted no less than four (4) days prior to the running of the trials. Issuance of a "NSF Check" or stopping payment on a check tendered to cover any fee shall be absolutely prohibited. Should an owner wish to have payment withdrawn from their Horsemen's Bookkeeper account, a notarized statement to that effect will be required as proof of such intention. There will be no refund of fees. All checks returned by the bank will constitute no payment. Any stop payment on a credit card will constitute no payment.

TRIALS.

Trials will be run under the same conditions as the final. Management shall restrict the field to 10 horses. Horses will be selected by order of finish in

the trials. A draw will determine which horses participate in the final if there is a tie.

If ten (10) or less horses enter the trials and the trials are canceled, only the ten (10) horses that entered the trials are eligible to enter the final. All horses must be declared official starters in the final of the Mountain Top NM Bred Thoroughbred Futurity, in order to receive any purse monies. All qualifiers must pass entry box.

Ruidoso Downs Racing, Inc. subject to the approval of the New Mexico State Racing Commission, reserves the right to change the date of the running of the trials and final, or to transfer this race to any track within the State of New Mexico. Ruidoso Downs Racing, Inc. reserves the right to cancel this race, without notice, at any time prior to the actual running thereof, without liability, except for the return of the nominating and sustaining fees which have been paid.

If a horse is disqualified from the final in the race because of a positive test during the trials, the horses which ran next in line by order of finish would draw to determine which horse would be advanced. If the front of the gates on the starting gate fail to open due to mechanical failure, or a horse is left behind the gate when the field is dispatched and money wagered on a horse is refunded to the public, such horse shall be declared a non-starter and all nominating, sustaining and entry fees shall be refunded from the purse to the owner of said horse.

The number of horses in each trial will also be decided by the management. Qualifiers are to be determined by order of finish in their respective trial division and not on time. Should a dead heat occur, the horses involved shall draw to determine which qualifies from the division. Should more than 10 trials be held, the division winners will draw to determine which 10 horses shall participate in the final. If a dead heat occurs in such a trial, those horses which dead heated in the trial will draw to determine which horse shall participate in drawing for the final. Any horse drawn out of the final by this method shall receive \$1,000 (deducted from the purse).

PURSE.

The nomination fees, sustaining fees and earned interest thereon, plus \$40,000 added, from the following entries: \$15,000 from the New Mexico Horse Breeders Association, \$10,000 from the Ruidoso Downs Racing, Inc. Purse Account and \$15,000 from the Ruidoso Horse Sale Company, will be distributed according to the payout schedule listed below.
