



Billy's Handicapping Contest

THE CONTEST

The contest will take place on Thursdays in June, July and August, in Billy's Race Book. Each contest will feature a different track, which will be announced prior to the promotion.

NO PURCHASE NECESSARY

There is no purchase necessary to enter this contest. Registration begins approximately one hour prior to post time at the selected track on the Thursday of the promotion. Forms for the first race must be filled out and returned to the contest table located in the Race Book prior to the start of the first race.

RULES

1. Registration will take place in Billy's Race Book
2. DEADLINE TO ENTER is prior to the first race of the designated track on the designated days.
3. Each participant must place a mythical \$2 win and \$2 place wager on each race at the selected track. The entire race card for the selected track will be mandatory plays. Players may select only one horse per race. Multiple wagers on different horses in any one race is prohibited. Official program numbers must be used when placing all wagers. Wagers are limited to WIN and PLACE only.
4. Contestants will be required to make their own selections on each race. Only one horse may be selected per race. No one will be allowed to select a horse for another participant. Selections are final after the designated race has started. Participants are responsible for returning their entry forms to the contest desk prior to the start of each race. No exceptions will be made.
5. The winner will be determined by the highest amount of fictional winnings at the end of the race card.

HOW TO ENTER

Each contestant will select one horse per designated race for a fictional win and place wager of \$2. Selection must take place at the Contest Table located in Billy's Race Book. All track rules apply as far as finishing positions. If there is a dead heat for third place both horses will be included in the official top three. At the end of the designated track's race card for the day, the participant with the highest total fictional winnings from his wagers will be declared the winner.

SCRATCHED HORSES

If a horse is scratched after the contestant has made their selection the contestant will be responsible for changing any selection prior to the start of the race. Changes may not be made after the race has started. If a change is not made the contestant will be given the post time favorite.

CANCELLED RACES

If any selected race is cancelled at the selected track, the contest results will be determined by the outcome of the remaining races.

TIE BREAKER

In the event of a tie, the prize money will be divided equally among the winners.

THE PRIZE

\$150 will be awarded to the winning contestant. If a tie exists, the prize money will be divided evenly among the winners.

REQUIREMENTS FOR CONTESTANTS

Contestants must be 21 years of age or older to win cash prizes at Ruidoso Downs Race Track and Casino. Liability for any and all federal, state, and local taxes rests solely with the prize winners.

Each registrant must fill out and turn in an official entry slip prior to the opening gates of the first race at the designated track.

Patrons must fill out their own registration form. Patrons must be present to win.

Patrons will be responsible for supplying their own programs, racing forms, and other handicapping materials.

INELIGIBILITY

The following are ineligible to participate in this promotion: Employees and immediate family of Ruidoso Downs Race Track, any affiliates, their advertising agencies and employees. For the purposes of this contest immediate family is defined as and includes any relative residing at the same residence.

JUDGING

Ruidoso Downs Race Track reserves the right to interpret all questions and conditions in regards to this contest, without claim for damage or recourse of any kind. All questions not covered in these rules will be decided by the management of Ruidoso Downs Race Track and Casino.
